## **CONDITIONS OF ENTRY**

- Juried entries are open to all Ontario artists in all media. All work must have been completed within the last 18 months.
- Works done in class, under instruction, copied from another source or previously exhibited at the gallery will not be accepted.

## **ENTRY FEE** (for up to three works):

Gallery Members: \$25.00

Not-yet Members: \$30.00

## **IMAGES**

Provide images of artwork on CD. Label CD with artist name. Number entries to correspond to the Entry Form. Images must be PC compatible, JPEG format.

Guidelines for image: 300 dpi, jpeg images. Only include submitted entries on the CD and please do not enter as a PowerPoint presentation. Contact the gallery if you need further direction.

## **NUMBER**

You may submit up to three entries.

## **DISPLAY**

All selected works must be ready for presentation. Two-dimensional work must be ready to hang with appropriate hardware and wiring installed. Three-dimensional work must be in stable display form. If necessary, any special installation instructions must accompany the accepted works.

**INSURANCE**

Submissions will be insured by the gallery while on gallery premises until specified pick up dates. Each work must be assigned a reasonable insurance value.

**EXHIBITION AGREEMENT**

By entering the jurying process the artist agrees to have their work available November 3, 2012 – January 3, 2013 for the duration of the exhibition. The artist grants the gallery permission to photograph works for publicity, educational and reference purposes.

**SALES**

Glenhyrst Art Gallery of Brant will receive a 30% commission on any sales resulting from this exhibition. Works are not required to be for sale.

**ARTIST EXHIBITING FEE**

A fee will be paid to the artist for each work exhibited according to CARFAC rates. Cheques will be issued within 30 days after the exhibition closes.

**AWARDS**

Includes a Jurors’ Choice, two Awards of Merit and an Honourable Mention.
